# COMPANY PROCEEDURE FOR SELECTING AND S/ON OF ROMANIAN CREW

#### 1. THE JOB OFFER

When notifying our office of your personnel requirements, by e-mail, or by phone, please include the vessels details (Name,type, Dwt, Gt, Engine with Bhp, IMO no and Call Sign), the required ranks of crew along with any special requirements, salary and period of contract, approximate date / port of employment.



The necessary time from the receiving the job offer till employment is 2-3 days, depending on the numbers of required personnel. The process of selecting and preparing the personnel takes approximate



1-2 days; this time is used to search our portfolio to select the perfect staff to match your requirements. At the same time we will verify the validity of all the candidate's documents, IMO certificates, Medical Examination, Alcohol/Drug Tests and previous experience. We also make sure we have contacted the candidate's previous employers in order to take references to further ensure the candidates suitability. After the initial process we then prepare an Application Form which we will send to your office (by e-mail) in order that you can preview our selection and either accept, or request further candidates.

After receiving the acceptance and the flight details with the agent's details and the port of call, we will need from your side the Employment Contract and all the necessary travel documents.



#### 3. VISA

In situations where a visa is necessary, we shall immediately inform your Company and our office will take care of all the required documentation in order for the visa to be issued. All we request from you is a letter of invitation / guarantee from either you or your agents in the port of boarding / disembarking.



#### 4. TRAVEL EXPENSES
